- C Enclose registration fee for each animal to be registered. Enclose registration and transfer fees for each animal to be registered. Enclose registration and transfer fees for each animal to be registered and transferred simultaneously. Current fee schedules are available from the ARBA office upon request. Certificates will not be processed without complete payment of the proper fees.
- D Applications must be printed or typed.
- E Sire owner signature (provided at left on this side of application) must be completed properly in order to process. Complete information on each appropriate calf which corresponds with the calf's information on the other side of this application.
- F Transfer on entry (provided above on this side of application) must be completed properly in order to process. For all calves that you wish to transfer, complete all information on each calf including that calf's private herd number, which corresponds with the calf's private herd number on the reverse side of this application. If you wish to transfer more than ten calves on entry from this application, please complete an additional transfer on entry form and write the page number in the space provided at the top of the transfer on entry form which corresponds with this application.

CALF PRIVATE HERD NUMBER — Calf's Private Herd Number. It must be unique within your herd.

SEX — Calf's Sex. (B=Bull, C=Cow or Heifer, S=Steer)

CALVING DATE — Calf's date of birth. (MM/DD/YY)

BIRTH WEIGHT — Calf's actual birth weight, measured within 24 hours of birth.

UDDER SCORE — (Measurement taken at time of calf birth) (1=Very Pendulous, 9=Ideal) For further details, refer to the Udder Score Reference Chart.

H/P/S — H=Horned, P=Polled, S=Scurred.

TWIN — Multiple (twin) birth code (1=single, 2=twin to bull, 3=twin to heifer, 4=other)

BIRTH GROUP — Dam's birth management group (1=MGMT Group 1, 2=MGMT Group 2, 3=MGMT Group 3, etc., maximum 2 characters). Assign a different MGMT group number for each group of dams managed differently.

COLOR — Calf's color. (1-Solid red, 2-Black nose, 3-Excessive white, 4-Any other, 5-Brindle, 6-Black hair coat)

BRAHMAN FRACTION — Calf's fraction Brahman breeding. (1/8, 1/4, 3/8, 1/2, 5/8, 3/4, 7/8)

WEANING DATE — Date calf weighed at weaning. Calves from a breeding season should be weighed within a 7-day period (MM/DD/YY).

WEAN WT — Weaning Weight. (Actual calf's weight taken between 110 and 300 days of age. Animals weighed outside this age span will be marked irregular for weaning ratio.)

WEAN MGMT — Weaning Management Type (0=Do Not Ratio*, 1=No Creep, 2=Creep, 3=Other, 4=Foster Dam*, 5=Raised as Twin*, 6=Twin Raised as Single*, 7=Embryo Transfer*) *No Ratio Calculated.

WEAN GRP — Calf's Weaning Group. (1=Group 1, 2=Group 2, 3=Group 3, etc. Maximum 2 characters) Assign a different MGMT group number for each group of cattle treated differently.

NAME — Calf's name (maximum 30 characters) ET calves must have the last 2 characters of the name be "ET". If you do not allow for this, the calf's name will be modified to accommodate.

Alternate use of NAME — If a female from your inventory has been disposed of prior to calving, then you can use the name field to record her disposal code and disposal date (see table for disposal codes).
